Pursuant to Section 466 of the *Local Government Act*, we advise you that a Public Hearing has been scheduled to consider these amendments to the Zoning Bylaw. ## What is the Proposal About?

If approved, Bylaw No. 2076 will amend the Medium Density Residential (R-3) zone to allow "Emergency Shelter", for up to 10 people, as a site-specific permitted use at 631 1<sup>st</sup> Avenue. Bylaw 2076 will also exempt 631 1<sup>st</sup> Avenue from the minimum dwelling unit floor area requirements of the R-3 zone.
